



OUTSTANDING CONTRIBUTION AWARD HALL OF FAME GUIDELINES

Individuals that have been determined to have made significant contributions to the promotion and support of youth trapshooting in the Eastern Cornhusker Trapshooting Conference (ECTC) shall be eligible for induction into the ECTC Hall of Fame as detailed under these guidelines.

Recipients of Hall of Fame status shall be awarded the following:

1. The Outstanding Contributions Award (OCA). The OCA Award will be a 7 inch by 14 inch solid walnut plaque in the shape of the State of Nebraska laser engraved with the name of the Conference, name of the recipient, years of service, and, the service(s) recognized for.
2. The name of the recipient shall be inscribed on the ECTC Hall of Fame Plaque which is permanently displayed at the Nebraska Trapshooting Association (NTA) Homegrounds in Doniphan, Nebraska.

Nomination Guidelines

1. Individuals shall be considered for nomination by submission of the ECTC Hall of Fame Nomination Form to the President a minimum of two weeks prior the Annual Board of Director's Meeting.
2. Nominations will be forwarded to the Awards Committee, which will screen and verify the accuracy of the written nominations, and, prior to the Annual Conference Board of Directors Meeting, present to the Board of Directors, for final consideration and approval at the Annual Meeting.
3. Only those individuals with a minimum of 15 accumulated points as detailed on the ECTC Hall of Fame Nomination Form shall be considered for nomination by the Board of Directors.
4. Points associated with years of service shall be verified by the Awards Committee.
5. Points associated with recognition for individual "Outstanding Contributions to the Conference" shall be as determined and voted upon by the Board of Directors at the Annual Meeting.
6. Upon accumulation of 15 points, as verified by the Awards Committee, nominees will be presented to the Board of Directors at the Annual Meeting for nomination to the Hall of Fame. All members of the Board of Directors will vote by ballot during the Annual Meeting. Ballots will be read aloud with the results announced. A majority vote by the Board of Directors is required for induction into the Hall of Fame.

The Outstanding Contributions Award(s) will be presented at the **GAYLE HANSHAW ALL-CONFERENCE SHOOT**.
